Inclement Weather Cancellation Policy: (Approved: March 14, 2006; revised Nov.22, 2010)

- 1) If Oxford Schools are cancelled or dismissed early, the scheduled Historical Society meeting will not be held.
- 2) If the weather forecast is for a storm that would make driving conditions dangerous, the President will contact the other officers to discuss canceling the meeting and make a decision. If the decision is to cancel the meeting, the officers will contact appropriate members to set the cancellation plan in motion.
- 3) The historian will call Channel 3 Television and post the cancellation on that station.
- 4) The Second Vice-President will email the membership who have electronic addresses.
- 5) The Corresponding Secretary will contact her telephone committee and call those members of the group who have no e-mail address.
- 6) A copy of this plan will be sent annually to persons obtaining a new membership or renewing a previous membership.
